

## **TERMS AND CONDITIONS - FREIGHT AND LOGISTICS**

- Our offers are based on the rates, tariffs and exchange rates (without engagement until the conclusion of the contract) valid on the date of the quotation
- Business undertaken is subject to Forwarder's Standard Terms and Conditions of the country where the contracted forwarder has its domicile in the valid wording
- Delivery periods and dates are read to be without engagement
- We neither liable for delays nor penalties of any kind
- The surface carriage can be substituted for airfreight or sea freight transportation in parts of the agreed route
- In no case shall our liability exceed the limits determined by the Warsaw Convention, CMR, CIM or by B/L – conditions
- Unless agreed in writing otherwise, invoices are due upon receipt
- Any expenses resulting from non-payment at customer's cost
- Transport to destinations (ports, facilities or other) come with 4hrs free time, additional hrs. charged at THB 500/hr/truck.



## **TERMS AND CONDITIONS - TRANSPORT**

- Transport is offered in line with clients request for service and any drawings, specifications received
- FPT operate transport in line to with the Thai Transport Depts rules and regulations
- Transport liability insurance is set at THB500,000/Incident
- If incidents occurred due to 3rd parties or any other incident
- deemed not the fault of FPT, we would not be held responsible
- If specific lashing or other transport requirements are needed, it should be advised in advance to enable FPT sufficient time to prepare accordingly
- Free time is issued to a maximum of 4hrs. Additional hrs. charged at THB500/he after that
- The delivery docket will be issued to the client upon completion of transport and will be used for operational and invoice purposes.



## **TERMS AND CONDITIONS – WAREHOUSING**

- Warehouse operating times Mon-Sat 0800 1730
- Full and Proper Pre-alert must be received in its correct fashion with correct details 48hrs before shipment arrival
- Client to advise approved stacking method of cargo if not advise received FPT have the right to stack as seen fit
- While every effort is made to unload cargo upon arrival, FPT provides a 4hr unload timeframe. This is in line with Most transport companies free-time and should not Inc it costs from our client's contractors (to be confirmed by clients with their relevant transport company)
- Equipment available on-site to handle cargo up to 3.5t anything above this weight is the notified one advance and quoted separately
- FPT provides warehouse liability to a maximum THB 1 million/ incident (copy available on request)
- FPT will not be held responsible for cargo inventory inaccuracies at anything than the level checked upon entry(pallet/box/piece).



## **TERMS AND CONDITIONS - PAYMENT AND CREDIT TERMS**

- Credit term base on the agreement between two companies and settlement will be limited according to final approval from FPT only
- Any advance payments made for and on behalf of clients will be subject to a cost + 10% admin fee
- All charges mentioned above are excluding any official receipts such as storage charges, duty and tax, etc
- A 7% VAT is applied on top of the total freight & charges collected in Thailand
- If not otherwise expressly agreed you have to pay the invoice immediately after receipt.
